8. Report from the Congress Committee and status of the Congress Iceland in June 2017

The organization is in place with four different committees to assist the host organizing committee with their work; a scientific committee, a social event committee, a marketing committee and a financial committee.

HOC will be working on the organization of a pre-conference for trainees, which might give better possibilities for the trainees to get economical support to attend the conference.

A possibility for the host organizing committee is to contact Christina Svanholm from FYAM (the Danish organization of young doctors) for assistance. Christina is also member of VdGM, and she will be a part of the new NYGP too.

NCGP in Denmark in 2019 will be in Aalborg, contract has been made with both conference venue and hotels. The Scientific committee is in place with 9 members including the chair, and the host organizing committee consist of three members.

NCGP in Norway in 2021 might be in Stavanger, - the discussion about venue will continue this summer.

Petter Brelin will take contact to Bernd Sengpiel, who will be able to assist with good ideas and advise for organizing a Nordic congress.

2016:

SJPHC fees cannot be raised already in 2016, and Helena therefore suggested an increase up to DKK 150.000 for royalties for the 2016-budget. This has been approved, and the subsidies will then increase with DKK 25.000 and go up to DKK 786.000 for 2016.

2017:

No amount yet allocated for the NYGF for 2017. Budget approved
